MUNICIPAL CODE SECTION 5.08.070 PERMIT REQUIRED. *No person or organization may conduct or allow another to conduct bingo games, and no person may act as a Bingo Manager in the City without first obtaining a permit from the City Administrator to do so. Upon completion and approval of the Bingo Permit Eligibility Application, payment of applicable fee, and upon receipt of a Certificate of Determination of Exemption from the California Franchise Tax Board showing that the organization is exempt from tax under subsections (a), (b), (d), (e), (f), (g), (k), (l) or (w) of Revenue and Taxation Code Section 23701, or a letter of good standing from the Exemption Division of the Franchise Tax Board showing an exemption under one of said sections (This subsection shall not apply to a mobile home park association, a senior citizens organization, or a school district.), the City Administrator may issue a Bingo Permit effective for one calendar year. If there are no changes to the original permit application, the Permittee may automatically renew by submitting the permit fee. If there are any changes to the original permit application, the Permittee shall submit a new application.*
