1.01.010 Adoption.

Pursuant to the provisions of Article 2, Sections 50022.1 et seq. of the Government Code, there is adopted the "Ripon Municipal Code" as published by Book Publishing Company, Seattle, Washington. (Ord. 381 § 1.01, 1987)

1.01.020 Title—Citation—Reference.

This code shall be known as the "Ripon Municipal Code" and it shall be sufficient to refer to said code as the "Ripon Municipal Code" in any prosecution for the violation of any provision thereof or in any proceeding at law or equity. It shall be sufficient to designate any ordinance adding to, amending, correcting or repealing all or any part or portion thereof as an addition, amendment to,

correction or repeal of the "Ripon Municipal Code." Further reference may be had to the titles, chapters, sections and subsections of the "Ripon Municipal Code" and such references shall apply to that numbered title, chapter, section or subsection as it appears in the code. (Ord. 381 § 2.01, 1987)

1.01.030 Codification authority.

This code consists of all the ordinances of general application of the city of Ripon, California, codified pursuant to the provisions of Article 2, Sections 50022.1 et seq, of the Government Code. (Ord. 381 § 3.01, 1987)

1.01.040 Ordinances passed prior to adoption of code.

The last ordinance included in this code was Ordinance 379, passed and adopted November 4, 1986. The following ordinance passed subsequent to Ordinance 379, but prior to adoption of this code, is hereby adopted and made a part of this code: Ordinance No. 380, an ordinance of the city of Ripon authorizing secondary residential units on residentially zoned lots in the city of Ripon and repealing all ordinances and parts of ordinances in conflict herewith. 1.01.050 Reference applies to all amendments.

Whenever a reference is made to this code as the "Ripon Municipal Code" or to any portion thereof, or to any ordinance of the city of Ripon, California, the reference shall apply to all amendments, corrections and additions heretofore, now or hereafter made. (Ord. 381 § 5.01, 1987)

1.01.060 Title, chapter and section headings.

Title, chapter and section headings contained in this code shall not be deemed to govern, limit, modify or in any manner affect the scope, meaning or intent of the provisions of any title, chapter or section of this code. (Ord. 381 § 6.01, 1987)

1.01.070 Reference to specific ordinances.

The provisions of this code shall not, in any manner, affect matters of record which refer to, or are otherwise connected with, ordinances which are therein specifically designated by number or otherwise and which are included within the code, but such reference shall be construed to apply to the corresponding provision contained within this code. (Ord. 381 § 7.01, 1987)

1.01.080 Effect of code on past actions and obligations.

Neither the adoption of this code nor the repeal or amendments hereby of any ordinance or part or portion of any ordinance of the city shall in any manner affect the prosecution for violations of ordinances, which violations were committed prior to the effective date of the ordinance codified in this chapter, nor be construed as a waiver of any license, fee or penalty at said effective date due and unpaid under such ordinances, nor be construed as affecting any of the provisions of

such ordinances relating to the collection of any such license, fee or penalty, or the penal provisions applicable to any violation thereof, nor to affect the validity of any bond or cash deposit in lieu thereof required to be posted, filed or deposited pursuant to any ordinance, and all rights and obligations thereunder shall continue in full force and effect. 1.01.090 Effective date.

This code shall become effective on the date the ordinance adopting this code as the "Ripon Municipal Code" shall become effective. (Ord. 381 § 9.01, 1987)

1.01.100 Constitutionality.

If any section, subsection, sentence, clause or phrase of this code is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this code. The council declares that it would have passed this code, and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases had been declared invalid or unconstitutional, and if, for any reason, this code should be declared invalid or unconstitutional, then the original ordinance or ordinances shall be in full force and effect.
